## Christl Monauni 1941 to 2018

Christl Monauni (born Szinicz), the beloved wife of Christian (Chris) and mother of Stefan and Philipp; the skiing, hiking, and trekking comrade of many Crested Butte people; and for many years a Mt. Crested Butte homeowner together with Chris, died in Denver on March 1 after suffering a ruptured cranial aneurysm in Crested Butte a week earlier.

Christl was born in Essegg (now Osijek), Croatia, on August 27, 1941. Toward the end of World War II she fled with her mother and three brothers to Austria. They settled in Linz, where she spent her school years, graduating in 1959 from the Handelsakademie Linz, one of the oldest commercial academies in Austria. She went on to study translating in Vienna and at the Sorbonne in Paris.

On March 9, 1968 she married Christian Monauni, whom she had known since childhood and who was working as a petroleum engineer in Great Yarmouth, England. After the wedding she packed all her belongings in a VW Beetle and drove from Austria to England to join Chris. In the next several years their two sons were born, Stefan in 1969 and Philipp in 1972. During the following three decades they lived in England; Wels, Austria; Turriff, Scotland; Tulsa, Oklahoma; London, England; and Houston, Texas, where they spent 15 years, until Chris retired. In 2004 they bought a farm at Monte Carlo, near Lucca in Italy, where they proudly produced their own brand of extra virgin olive oil, and where they graciously entertained friends from Crested Butte. In 2017 they sold their farm and moved to Linz.

In the early 1990s Christl and Chris bought a condo in Mt. Crested Butte, and they returned here each year to enjoy skiing and the company of their friends. Christl was a devoted and active member of the Butte Beauties, both on the slopes

and at weekly poker games, where she was known for maintaining a "poker face" even when holding all the aces.

Over the last two decades Christl and her husband also enriched the experience of Crested Butte friends by organizing treks across the Italian Dolomites, the Scottish Highlands, the Spanish Pyrenees, and the Dachstein in Austria, as well as participating with Crested Butte friends in a 100-mile trek around the Dingle Peninsula in Ireland. She loved her time in Crested Butte, and spent the days before her illness with her friends and husband, skiing and enjoying the winter.

Christl Monauni leaves her devoted husband; their sons Philipp (and wife Jessica) and Stefan (and wife Erin); their grandchildren Elizabeth, Olivia, and Makaila; and her brother, Prof. Dr. Gerhard Szinicz, a retired surgeon.

Her many friends will always remember her with love and admiration.






