Supreme Court slams Union Park curve ball

An unusual turn in the effort to divert local water to feed the Front Range was shut down recently. The Union Park Water Authority had filed a motion to block a local agreement that has been more than 40 years in the making. However, the Colorado Supreme Court made "quick work" of the motion, denying it earlier this month.

Since 1982, there has been a push to pipe 60,000 acre-feet (nearly 2 billion gallons) of local water over the Continental suburbs. However, the Union Park project, which would tap into numerous local creeks and rivers, has been deadlocked in court virtually since its inception. Water Court judge Robert Brown has twice ruled that there is not sufficient water locally to serve the Front Range's needs. Courtesy of an Arapahoe County appeal, Union Park should be before the Colorado Supreme Court after February 28 (2000).

A separate effort has been in the works for more than 40 years and is also currently awaiting its conclusion. When the Aspinall Unit (Blue Mesa, Crystal and Morrow Point reservoirs) was created in 1957, the Bureau of Reclamation made a big promise to Gunnison County residents. In

exchange for creating three reservoirs and covering the Gunnison River, the bureau agreed to give up 60,000 acre-feet of water a year. The water would be available for future Gunnison County use under a subordination agreement. To date, subordination has existed, but a document outlining the 1957 agreement has not been put on the books. There is hope that such a document will be created in the near future.

In late December these issues collided when the Union Park Water Authority filed a motion asking the Colorado Supreme Court to prevent the subordination agreement from being executed.

John Henderson, Arapahoe County attorney, explained the rationale behind the motion, saying, "The [subordination] agreement's environmental analysis is accompanied by the findings that the court made on Union Park." As a result, the Union Park Water Authority wanted to see these findings formalized by the appeal before the agreement was

In addition, the authority recently sent a lengthy letter to the Bureau of Reclamation in an effort to derail the subordination agreement. Upper Gunnison board member Steve Glazer read the letter and said, "It's as if they're trying to retry the Union Park case all over again before the Bureau of Reclamation. I got the impression that they're being very aggressive with those comments."

However, the authority's efforts before the Colorado Supreme Court apparently were not aggressive enough. The court quickly denied the motion on January 4, and on January 19, the court also denied a Union Park effort to reply.

"The Supreme Court ruled very quickly that it was denied. They turned it down basically out of hand," noted Dick Bratton, attorney to the Upper Gunnison River Water Conservancy District, an active Union Park opposer.

Henderson said, "I wish the Supreme Court had offered us more illumination, but they denied it without comment. When they make no comment, there's really no analysis you can offer."

Bratton said the Union Park motion was irregular, but amounted to no more than an annoyance for the opposition. "It didn't have any impact on the outcome of the main case [the Union Park appeal]," he

Efforts to defeat the main Union Park case again are

going full-bore. Last Monday, the Upper Gunnison board signed off on contributing up to \$4,000 to a review of the opposition's briefs and motions. Gunnison County and the Colorado Water Conservation Board ponied up similar sums, and the city of Gunnison has been approached for a \$3,000 contribution. Two former Supreme Court justices have been retained, and as Bratton noted, "The idea is to get some insight on the Supreme Court review."

The Union Park Water Authority is taking a much more relaxed approach to the upcoming trial. Saying that the Colorado Supreme Court typically gives parties six weeks notice for the trial's opening. Henderson said, "When we receive notice, we'll begin to gear up for oral argument. Heaven knows, we've been at this for ten years now, and there's more than enough paperwork lying around."

Bratton said he is expecting a day in court on February 28, but "It's possible it will be a little later."
