1944-2021

It was 1976 when Jim, Sandy and 11-year-old Darby pulled into Crested Butte in a Chevy Van, towing a 16' Hobie Cat sailboat. Having been part owners of a medical publishing company in New England, they were looking for a more natural and enjoyable life. They settled at 425 Elk Avenue, where they remodeled the house and lived for the next 10 years. Jim was part owner in Crested Butte Auto and Towing, while Sandy had the Crystal Palace Silversmith.

The Sullivans then designed and built a totally solar log home in the Irwin townsite, snowmobiling in and out for the next 10 years. Jim was the lead guide for the Irwin Lodge, while Darby went to CSU for her Equine Sci-

ence degree.

Jim was a wonderful, kind, loving husband and father. He and Sandy were married for 56 years and so proud of their daughter. Darby owns Rocky Mountain Veterinary Services and is married to Martin Klinowski in Gunnison.


Jim comes from a family of five siblings, three of whom have preceded him in death, sisters Jean French and Mary Jane (Richie) Smith and brother Dan (Mary) Sullivan. His remaining brother is David (Camelia) Sullivan of Andover, MA. Jim graduated from Stone Hill College with a BA degree.

Jim was full of adventure, a hard worker and a talented craftsman. He and Sandy designed and built their second passive solar

home on 45 acres at the Roaring Judy Ranch in Almont. This was Jim's dream home, which he continually created and perfected. He was a respected builder with many passions, skiing, sailing his 45' sailboat, building wooden canoes, enjoying Costa Rica, and, as a sports car enthusiast, even building a hot rod at the age of 16.

Jim passed away peacefully from cancer January 28, 2021 in Hyannis, Cape Cod. He was by the ocean he loved and with his family. He will be so missed!

## Western Trustees invite community to listening session

The Western Colorado University Board of Trustees wants to hear from Gunnison Valley community members. The board is hosting a one-hour virtual listening session for community members on a variety of topics.

The listening session will be held on Zoom on Tuesday, April 13, from 5-6 p.m. A Zoom link will be sent upon registration.

In an effort to improve Trustee communications and outreach, the board's objective in this session is to listen and learn from the various constituents. The Trustees seek to understand perspectives, build relationships, strengthen trust and learn how they can better govern to build a stronger Western where students thrive.

Specifically, the board wants input on Western's strengths and challenges that either helps us achieve success or that hinders us. They want to know what community members see as opportunities and threats to long-

term success and service in our region.

Each session is open to an unlimited number of participants, and limit the maximum number of individuals wanting to speak to 25.

The board commits to sincerely listening to the information from the array of voices intended to assist them in thoughtful governance of Western. The trustees ask all participants to appreciate these communications are part of an ongoing and continuous process.

All participants will be asked to follow a set of ground rules, such as:

- Adhere to the allotted time of two minutes maximum per speaking opportunity (which could be shortened depending on the number of participants.)

- Register for a speaking slot and wait to be called on prior to speaking (repeat speakers may be allowed when everyone has had a turn.)

- Those who wish to express their thoughts are also welcome to submit

written information to the board.

- When called upon to speak, introduce yourself (name) and affiliation.

- Employ respectful and collegial dialogue.

- No personal attacks of anyone.

- Do not feel like you must speak. Listening attendance is welcome.

- If you have video capabilities, it is highly encouraged to enable your video.

The trustees are eager to hear about proposed actions and constructive solutions, and are open to scheduling more sessions in the future.
