Rage in the Sage showcases local strength

Mountain bike racers from Gunnison and Crested Butte put on a display at Hartman Rocks for the hometown crowd Saturday and Sunday at the 18th running of the Wells Fargo Rage in the Sage, part of the Spirit of the Rockies series.

On Saturday, observed trials and the downhill were the order of the day. Gunnison resident Ken Bloomer would have nothing of multi-gear, downhill specific bikes with seven inches of suspension travel front and rear. He raced for the Novo-Sycips team taking second place in the expert men 30-39 category on a single-speed bike with a rigid

fork. Tuneup bike shop prodigy/mechanic extraordinaire Ryan Palmer won the beginner men 19 plus category by two seconds over fellow Gunnison resident Kevin Kruse. Carol Quinn decided last minute to race in the sport class on a borrowed bike taking first.

Earlier in the day, Quinn's daughter Rebecca Dussault won the women's stock trials competition. In observed trials, riders displayed their bike handling prowess near and sometimes over precipitous drops and steep climbs, all while trying to avoid a "dab" or putting a foot down for balance. Dussault's husband Sharbel Dussault took home the glory in the sport modified division. Gunnison resident Kevin Noreen took first in the beginner modified category.

Then Sunday arrived. The sun shown brightly on the 21-

mile cross-country course and the wind, well it blew. The pro men and experts left the gates at 9 a.m. for a two-lap adventure on trails so graciously softened by bovine spectators. The first racer back to the start/finish line after the first lap was Gunnison resident Jon Brown, teammate of Bloomer with Novo/Sycips. He had a commanding three-minute lead which only grew larger in the final lap. Brown ended up finishing the grueling race in 2:49, seven minutes ahead of Grand Junction racer Ross Schnell of Team Devo.

"I took it easy the first lap, and so the second lap I felt really strong," commented Brown. "I'd like to thank Rage in the Sage for a great event, Wells Fargo (title sponsor for the race) and Sycips Bikes."

Jennifer Hopkinson-Smith of Gunnison (Dean-Tuneup), former standout cross-country runner at Western State College, won the women's expert division in a time that proved to be the fastest women's time of the day.

The single-speed sickos took the course later at 1:45. Gunnison resident Kevin Tan took first with a time of 1:35:24 followed closely by hometown boy RB Bathje in 1:38:52.

Crested Butte's Chad Oleson, racing with Handle Bar & Grill,

took ninth in the men's expert 30-39 class with a two-lap time of 3:18:02.

Kelly Kiefer, Crested Butte resident, took second in the beginner women 19-29 division.

Crested Butte standout Nordic racer Travis Scheefer (racing for Tuneup) continued his success into the summer season taking third in the expert junior men 13-18 division with a strong, early season time of 1:41:25. Noreen continued his strong showing finishing ahead of the pack in the junior men beginner 15-16 category.

And Sarah Garcia, racing for her dad Rick, co-owner of the Tuneup, took first position in the junior women 15-16 division.

In all, 380 racers showed up for the festivities. One of the longest running races in the country, Rage in the Sage is a NORBA "Classic" event. Come out next year to keep the tradition going.

The staging area will be surrounded by landscape boulder seating and site fixtures including a signage kiosk, bike racks, and paddle board storage. The river is accessed via stone slab steps with a wooden boat slide stabilized by a boulder retaining wall. The beach area will be enhanced with cobble river rock. The project includes enhanced native vegetation with temporary irrigation and the relocation of an infiltration and drainage area.
