

John "Jack" Howard Barney

May 6, 1934 – November 2, 2022

Jack Barney died at home, surrounded by loving family members in Whitefish, Montana on November 2, 2022. He was 88 years old. Jack was born in Denver, Colorado on May 6, 1934, the first son of Howard and Nora Barney. Nora's father and Jack's grandfather, John O'Toole, came to Colorado during the Irish potato famine, in search of a clean start in the mining towns of Colorado.

He grew up in the Washington Park neighborhood of Denver. As a young man he enjoyed ice skating, fishing and both water and alpine skiing. He attended the Colorado School of Mines, graduating with degrees in Chemical and Petroleum Engineering. He furthered his education in Maryland earning a law degree LLB from the University of Baltimore. While in the Maryland area, he was lucky enough to catch the eye of Margaret Sullivan. They swiftly fell in love and began their adventurous life together.

Married on June 24, 1961, Jack and Margo headed west. They lived and worked in various locations from Long Beach, California to Parachute, Colorado, while Jack pursued his career in engineering having five children along the way. In 1971, they settled in Coal Creek Canyon, Golden, Colorado, where they raised Mike, John, Paul, Jim, and Megan Barney. Later in life, they lived in Crested Butte and Montrose, finally landing in Whitefish, Montana.

Jack worked most of his career developing new ways to refine oil from oil shale for the Tosco corporation based

in Denver. His creative mind led him to develop multiple patents in techniques used to extract oil from oil shale. Later when oil shale became economically unviable as a fuel source, he switched horses and became the owner/operator of Evergreen Analytical. With Margo at his side, they enjoyed working day in and out with the hard-working staff that produced "quality data on time" in the environmental testing field for businesses and municipalities nationwide.

Jack was known for being the smartest and hardest working guy in the room. He was also appreciated for his honesty. Sometimes, he was known for being a bit too honest. He was the PTA president, soccer coach, boy scout leader, and so on and so forth... He inspired his children to embrace a sense of adventure in the mountains of Colorado. He circumnavigated the world with Margo and their close friends in 1997. In 2008, Jack suffered a major stroke. However, this did not stop his determination to heal himself. Over the next 14 years, he worked hard on strengthening both his body and mind. In doing so, he was the presiding member at countless family gatherings and grandfather to his six grandchildren.

He will be lovingly remembered at a Celebration of Life ceremony at the Coal Creek Canyon Improvement Association in Golden, Colorado on Sunday, November 14 at 1:30 p.m. The interment of his ashes will be held



Monday, November 13 at Mt. Olivet Catholic Cemetery in Wheat Ridge, Colorado at 11 a.m. All are welcome to attend either or both ceremonies. We look forward to hearing your memories and tales of mischief and adventure. Please RSVP to jamesebarney@gmail.com if you plan to attend.

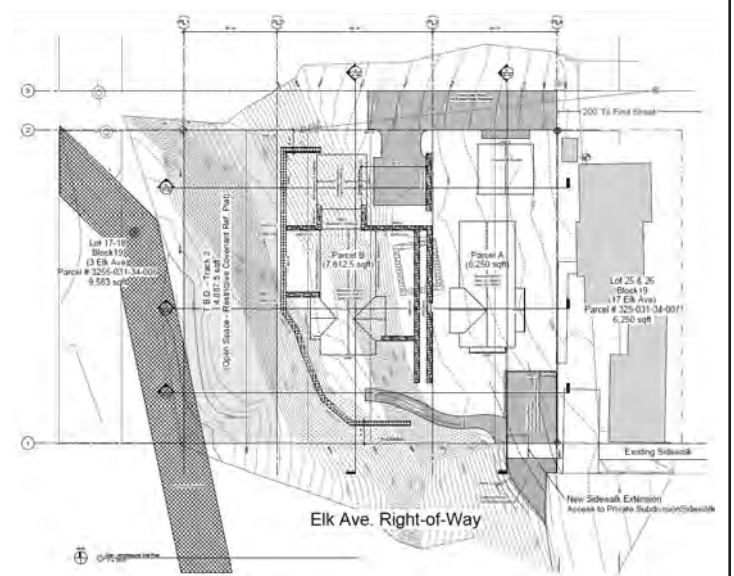

SERIES 2022**

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF MT. CRESTED BUTTE, COLORADO, AMENDING CHAPTER 2. ADMINISTRATION, ARTICLE V. PUBLIC HEARINGS, DIVISION 2. PLANNING COMMISSION HEARINGS AND DIVISION 3. TOWN COUNCIL HEARINGS, AND REFERENCES THERETO, OF THE CODE OF THE TOWN OF MT. CRESTED BUTTE, COLORADO WHEREAS, certain provisions of the Code of the Town of Mt. Crested Butte, Colorado, require the Planning Commission and Town Council to hold public hearings prior to action of the Planning Commission and Council; and WHEREAS, the Code also requires in certain instances that property owners within 200 feet of the exterior lot lines of the property for which the application is pending be notified of the public hearing; and WHEREAS, by Ordinance No. 2, Series 2021, of the Code was revised to clearly address when the notice to adjoining property owners must be mailed; and WHEREAS, for reasons unknown, the Ordinance approved by Council contained a reference to 15-days notice as opposed to the staff recommended amendment to require mailing by certified mail at least 18 days prior to the date of the public hearing; and WHEREAS, this Ordinance is intended to remedy that oversight. NOW, THEREFORE, BE IT ORDAINED BY

THE TOWN COUNCIL OF THE TOWN OF MT. CRESTED BUTTE, COLORADO, THAT: **Section 1.** Chapter 2. Administration, Article V. Public Hearings, Division 2. Planning Commission Hearings is hereby amended to read as follows: **Sec. 2-277 Notice** Not less than eighteen (18) days prior to the date set for the public hearing, the town clerk shall cause a copy of a notice of the time and place of such hearing to be published once in a newspaper of general circulation in the town. Not less than eighteen (18) days prior to the date set for the public hearing, a copy of such notice shall be mailed by the applicant by certified mail to the owners of all properties within a radius of two hundred (200) feet of the exterior lot line of the lot, tract or property affected by such hearing. Amendments to the subdivision and zoning ordinances of the town, instituted by the town do not require notice mailed to property owners. **Section 2.** Chapter 2. Administration, Article V. Public Hearings, Division 3. Town Council Hearings, is hereby amended to read as follows: **Sec. 2-301 Setting date, time; notice; proof of ownership; bases for determinations; presentation of testimony, evidence** In the event that a recommendation of the Planning Commission concerns an amendment to either the subdivision ordinance or to the zoning ordinance, then upon receipt of such recom-

mendations, the town clerk shall set a date and time for a public hearing upon such application before the town council, to be held no sooner than eighteen (18) days and no later than forty-two (42) days. **Notice.** For all other hearings, not less than eighteen (18) days prior to the date set for the public hearing, the town clerk shall cause a copy of a notice of the time and place of such hearing to be published once in a newspaper of general circulation in the town. Not less than eighteen (18) days prior to the date set for the public hearing, a copy of such notice shall be mailed by the applicant by certified mail to the owners of all properties within a radius of two hundred (200) feet of the exterior lot line of the lot, tract or property affected by such hearing. Amendments to the subdivision and zoning ordinances of the town, instituted by the town do not require notice mailed to property owners. **Proof of ownership.** The applicant shall provide, at its sole cost and expense, a title-commitment issued by a title insurance company authorized to transact business in the state, evidencing ownership, with an effective date within twenty (20) days of the date of the application, which commitment shall also evidence the addresses of such owners, as evidenced by the records of the county clerk and recorder. A title opinion prepared by an attorney-at-law licensed by the state may be provided in lieu of such title commitment.

Bases for Determination. The town council shall base its determinations upon statements contained in the application or petition, upon reports from the town staff or consultants, if any, upon recommendations and findings of the planning commission, and upon evidence presented to the council at the hearing. **Section 3.** Severability. Should any section, clause, phrase, or provision of this ordinance be ruled invalid or unenforceable by any court of competent jurisdiction, it is hereby declared the intent of the Town Council of the Town of Mt. Crested Butte, Colorado, that the remaining provisions of this ordinance shall be given full force and effect if it is possible to do so.
