Gunni Packs: In 2024, 2,401 Gunni Packs—each with six meals, six snacks, and one drink—have been delivered weekly to children's homes, providing 16,401 weekend

Mini Pantries: Emergency food, accessible through a trusted adult, is available to Gunnison Watershed School District school for children

to eat immediately or take home.

Healthy Snacks: In 2024, 91,248 servings of healthy snacks have been distributed monthly to local schools, public libraries, and families with school-age children.

During the school year, these programs are supplementary to government initiatives such as free-and reduced-lunch but during summer break, the federal

programs are paused. This means that for almost 75 days, starting at the end of May, food insecure families are entirely reliant on Pantry services. To ensure no one goes hungry, GFCP ramps up its programming during these months to meet the increased need by distributing food directly to individuals in need, in their neighborhood, in the form of the Fresh Mobile Pantry. In the summer of 2024,

the Fresh Mobile Pantry had 961 visits.

With the need clearly on the rise, grant funding is a major pillar in supporting our work, but it isn't the only one. The consistent volunteer time, food and monetary donations from individuals and businesses in our community form the foundation on which everything else gets done. January-March, volunteers have donated an incredible

1,888 hours towards feeding their neighbors. Those hours went towards distributing food to 1,289 unique individuals or 654 households, who visited the Pantry 2,992 times in 2025.
